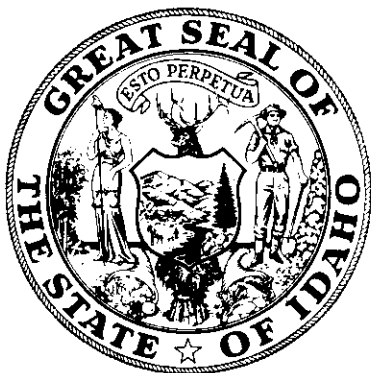

ARTICLES OF AMENDMENT

TO

SECRETARY OF STATE INTERMOUNTAIN SATELLITE TV, INC.

These Articles of Amendment and the following Certificate are hereby made and executed pursuant to Section 30-1-61, Idaho Code, for the purpose of amending the Articles of Incorporation of Intermountain Satellite TV, Inc., an Idaho corporation, and to effect an increase in the authorized capital stock of said corporation. The undersigned, Robert M. Johnson, President of said corporation, and Ilene Johnson, Secretary of said corporation, do hereby respectfully certify as follows:

I.

That a Consent in Lieu of Special Meeting of the Stockholders of Intermountain Satellite TV, Inc., an Idaho corporation, has been executed by all of the stockholders of the corporation approving the amendments set forth herein and that said Consent in Lieu of Meeting is filed in the Minute Book of the corporation.

II.

That in the aforementioned Consent in Lieu of Special Meeting the following resolution was presented and unanimously adopted.

BE IT RESOLVED That Article Fourth of said Articles of Incorporation be amended to read as follows:

"FOURTH"


The aggregate number of shares which the corporation shall have the authority to issue is 20,000 shares at a par value of \$5.00 per share.


BE IT FURTHER RESOLVED That the aforementioned increase in the capital stock of the corporation will be from \$10,000.00 divided into 200,000 shares of .05 cents par value each to \$100,000.00 divided into 20,000 shares with \$5.00 par value each.

BE IT FURTHER RESOLVED That the President and Secretary of the corporation respectively, be and they hereby are authorized to prepare a Certificate of this resolution and amendment to the Articles of Incorporation of the corporation and to file the same with the Secretary of State of the State of Idaho and to do all things necessary in order to fully effect the increase in the authorized capital stock of this corporation in accordance with this resolution.

We further certify that we are the proper officers to execute this certificate, being the President and Secretary of said corporation and we, therefore, execute these Articles of Amendment to the Articles of Incorporation of said corporation.

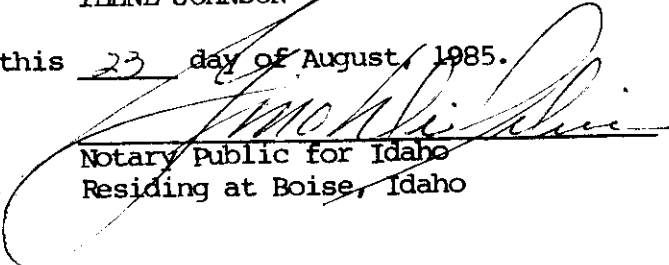
