

## ARTICLES OF INCORPORATION

OF

BARBARA, BARBARA AND COMPANY, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is BARBARA, BARBARA AND COMPANY, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose for which the corporation is organized is the transaction of any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 10,000 shares, divided into two classes (Class A Voting, Class B Non-Voting) of five thousand (5,000) shares per class, non-assessable common stock, each having a par value of one dollar (\$1.00).

FIFTH: Shareholders of each class shall have preemptive rights to acquire unissued or treasury shares of the same class only. No other preemptive rights shall exist.

SIXTH: Provisions for the regulations of the internal affairs of the corporation are: none.

SEVENTH: The address of the initial registered office of the corporation is 10026 Vixen Drive, Boise, Idaho 83709, and the name of its registered agent at such address is Robert C. Krogh.

EIGHTH: The number of directors constituting the initial board of directors of the corporation is five (5), and the names and addresses of the persons who are to serve as directors until the first annual meeting of shareholders or until their successors are elected and shall qualify are:
