ARTICLES OF INCORPORATION
OF
SNAKE RIVER STAGE LINE, INC.

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation shall be **Snake River Stage Line, Inc.**

ARTICLE II

The corporation shall have perpetual existence.

ARTICLE III

The purpose or purposes for which the corporation is organized is to engage in any lawful business. Without limiting the preceding statement, the corporation is also organized for the purpose of but not limited to providing tours of the Three Island Park and surrounding area in a stagecoach.

ARTICLE IV

The aggregate number of shares which the corporation shall have authority to issue is 10,000, all without par value. The corporation, if appropriate, may authorize and issue shares of preferred or special classes as provided in Idaho Code §30-1-601.

ARTICLE V

The mailing address of the initial registered office of the corporation is P.O. Box 730, 415 E. 4th Street, Glens Ferry, Idaho 83623, and the name of its initial registered agent at such address is Dale Jeffrey.

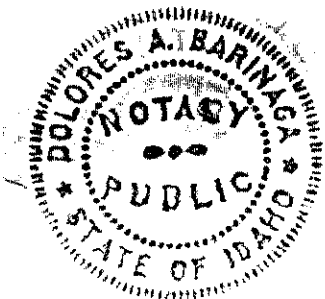
