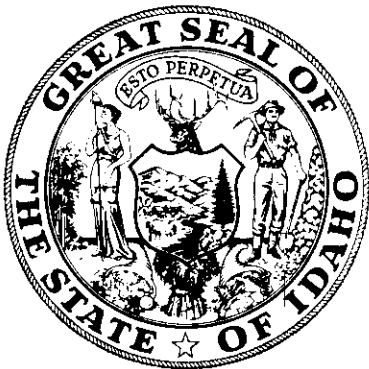

TO  
ARTICLES OF INCORPORATION

The undersigned, Larry Grover, president, and W.R. Parker, secretary, of Idaho Implement, Inc., hereby certify and respectfully represent the following:

That Idaho Implement, Inc., is an Idaho Corporation, duly organized and existing under the laws of the State of Idaho, having been incorporated on the 3rd day of January, 1983; that a meeting of the Shareholders of Idaho Implement, Inc., was duly called by written notice given by the secretary more than thirty days prior to the date set for such meeting; that a copy of said notice was provided to each shareholder, and such notice was to the effect that the shareholders would be called upon to act on a proposed amendment to the Articles of Incorporation to change the name thereof.

That said Shareholders meeting of Idaho Implement, Inc., was held on the 31st day of March, 1986, at Idaho Falls, Idaho, at which meeting all of the owners of the outstanding shares of stock of the corporation were present in person, and each was in attendance throughout the entire meeting. That the shareholders so attending are also the directors of the corporation, and by affirmative unanimous vote of all of the shareholders of the corporation and the directors there was adopted a resolution amending the Articles of Incorporation as hereinafter set forth.

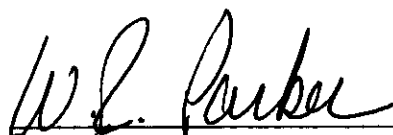
That the resolution adopted by the shareholders amending the Articles of Incorporation is as follows:

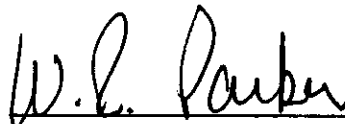

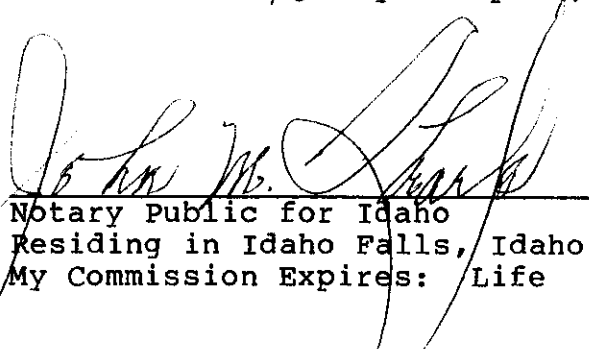
