
ARTICLES OF INCORPORATION

- Article I The name of the corporation is:
FLOWERS TO GO, INC.
- Article II The term of existence shall be perpetual.
- Article III Said corporation is organized to purchase, produce, acquire, manufacture, import or otherwise acquire, sell, import, export, distribute and deal in goods, wares, merchandise and material of any kind and description, primarily flowers and related merchandise.
- Article IV The corporation shall have the authority to issue one-hundred (100) Shares of Common Stock, each share to have No Par Value. The shares may be issued for the consideration expressed in dollars as may be fixed from time to time by the Board of Directors.
- Article V The corporation shall have an initial capital investment of one-thousand dollars (\$1,000.00).
