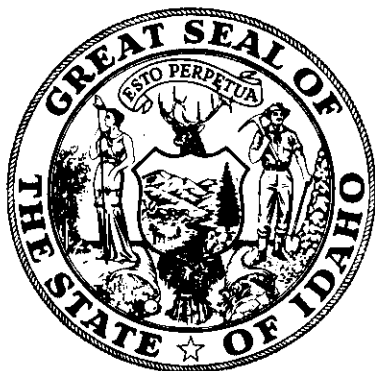

WILLIAM SELLERS INDUSTRIES , INC.

KNOW ALL MEN BY THESE PRESENTS, that we, the undersigned being natural persons over the age of eighteen (18) years, do hereby form a general business corporation under the laws of the State of Idaho as contained in Title 30 of the Idaho Code entitled "General Business Corporations Act", and to that end do hereby set forth:

1. The name of the corporation is:

WILLIAM SELLERS INDUSTRIES, INC.

2. The period of duration of this corporation shall be perpetual.

3. The purposes for which this corporation is organized are:

(a) Primarily to engage in the business of manufacturing, installing and servicing machinery for the use in storing and perserving agricultural products.

(b) The transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.

4. The county in the State of Idaho where the principal office for the transaction of business of the corporation is located is in the County of Ada and the name of the registered agent is William Sellers and the address of the registered office shall be 8053 Hill Road, Boise, Idaho.

5. The aggregate number of shares which the corporation shall have authority to issue is 100, having no par value. All of said stock shall be known as common stock and shall be nonassessable.

10 stock.


11           8. The number of directors of the corporation may be
