ARTICLE I

The name of this corporation shall be:

ARTICLE II

The purposes for which this corporation is formed are:

(a) To manage, operate and control the Heidelberg Motel and any other properties falling under the managerial jurisdiction and control of the corporation.

(b) To carry on generally the real estate business; buying and selling real estate, mortgaging and acting as a real estate business in all matters generally handled by real estate businesses and corporations.

ARTICLE III

The principal place of business of said corporation shall be Ketchum, Blaine County, State of Idaho.

ARTICLE IV

The term of this corporation shall be perpetual.

The corporate power and business shall be exercised and controlled by a board of three directors.

ARTICLE VI


The amount of the capital stock shall be \$10,000.00 divided into 100 shares of common stock having a par value of \$100.00 per share.




