OF

We, whose names are hereunto subscribed, all of whom are citizens of the United States of America and bona fide residents of the State of Idaho, and each of us being of full legal age, do under and pursuant to the general corporation laws of the State of Idaho, associate ourselves together for the purpose of becoming a body corporate, and do now declare these are the Articles of Incorporation of HEIDELBERG INN; INC.; a corporation.

#### ARTICLE I

The name of this corporation shall be:

#### ARTICLE II

The purposes for which this corporation is formed are:

- (a) To manage, operate and control the Heidelberg Motel and any other properties falling under the managerial jurisdiction and control of the corporation.
- (b) To carry on generally the real estate business; buying and selling real estate, mortgaging and acting as a real estate business in all matters generally handled by real estate businesses and corporations.

## ARTICLE III
