

5 The undersigned, acting as incorporators of a corporation
6 under the Idaho Business Corporation Act, adopts the following
7 Articles of Incorporation for such corporation:

8 FIRST: The name of the corporation is POXLEITNER PRODUCTS,
9 INC..

10 SECOND: The period of its duration is perpetual.

11 THIRD: The purpose or purposes for which the corporation is
12 organized are: the transaction of any or all lawful business for
