ARTICLES OF INCORPORATION OF HI-TECH HEATING AND AIR CONDITIONING INC.

TO CREATE A CORPORATION UNDER THE TRADISATING OF THE CORPORATION LAWS OF THE STATE OF IDAHO, WE, THE FOLLOWING PERSONS, DO HEREBY ASSOCIATE OURSELVES, AND CERTIFY AS FOLLOWS:

ARTICLE 1

THE NAME OF THIS COMPANY SHALL BE HI-TECH HEATING AND AIR CONDITIONING, INC.

ARTICLE 2

IN FURTHERANCE OF THE GENERAL POWERS OF THIS CORPORATION, IT SHALL HAVE THE TECLLOWING PRIVILEGES IN ITS BUSINESS:

- A. TO PURCHASE, LEASE, OR DEAL IN REAL PROPERTIES OF ALL DESCRIPTIONS
- B. TO PURCHASE, LEASE, OR DEAL IN PERSONAL PROPERTY OF ALL KINDS
