AMENDMENT TO ARTICLES OF INCORPORATION

OF

COMES NOW, SETH WOOD FARMS, INC., and hereby amends its Articles of Incorporation as follows:

1. Article VI of the Articles of Incorporation shall be amended to reduce the number of Directors from three to two as follows:

"At the annual meeting of the Shareholders there shall be elected from the shareholders of this Corporation a Board of Directors consisting of such number of members, not less than two as shall be provided by the By-Laws. The Directors shall hold office for the term of one year until their successors are elected and qualified."

2. That amendment was adopted by the Directors and Shareholders on February 6, 1989.

3. There were ~~one hundred and ten~~ shares outstanding and entitled to vote, and all of said shares voted in favor of said amendment.

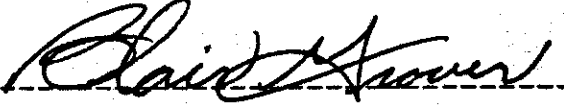
