 $\underline{\textbf{FIRST}}$: The name of the corporation is Purity Water, Inc.

SECOND: The period if its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

- (a) To sell bottled water and lease or sell bottled 'water containers, coolers, dispensers and related equipment, to sell or lease water softeners, dispensers, salts and chemicals and to do all types of business related thereto on its own behalf or the behalf of others.
- (b) To carry on any other kind of business or business activities that the Board of Directors may from time to time deem to be advisable or proper in connection with the business.
- (c) To purchase, lease, own, sell, mortgage, sublease, and otherwise acquire lands, buildings, easements or property, real and personal, which may be requisite for the purposes or are capable of being conveniently used in connection with any of the objects of this corporation, and to
