 - (d) no amendment to any provision of this Agreement shall become effective without prior written consent of FmHA;
 - (e) the affairs of the Partnership shall be subject to FmHA regulations and no action shall be taken which would require the consent or approval of FmHA unless the same is first obtained.

No new general partner shall be admitted to the Partnership and no general partner shall withdraw from the Partnership or be substituted without the prior written consent of FmHA if such consent is then required.

Any conveyance or transfer of title to all or any portion of the apartment complex(es) required or permitted under this Agreement shall in all respects be subject to all conditions, approvals and other requirements of FmHA rules and regulations applicable thereto.
