ARTICLES OF INCORPORATION OF THE ACME PLUMBING
AND HEATING COMPANY, LIMITED.

Know All Men By These Presents, That we, the undersigned, have this day voluntarily associated ourselves together for the purpose of forming a Corporation under the laws of the State of Idaho,-

And we hereby certify:

First; That the name of said corporation is the Acme Plumbing and Heating Company, Limited.

Second. That the purposes for which it is formed are to engage in and carry on a general wholesale and retail hardware, plumbing and heating business; to manufacture, buy and sell hardware, plumbing and heating, including gas and hot-water apparatus, fixtures and supplies; to instal the same in public and in private buildings and other structures, and to do all kinds of sheet iron, metal and tin work; and generally to do and perform all business and acts essential, necessary or proper to the transaction of said business anywhere in the State of Idaho, or elsewhere.

Third. That the place where its principal business is to be transacted shall be Boise, Ada County, Idaho.

Fourth. That the term for which it is to exist is fifty years from and after the date of its incorporation.

Fifth. That the number of its Directors shall be five, and that the names and residences of those who are appointed for the first year are:
