We, the undersigned President and Secretary of Valley Chemical & Fertilizer, Inc., do hereby execute these Articles of Amendment to the Articles of Incorporation of Valley Chemical & Fertilizer, Inc., pursuant to resolutions of the shareholders and directors of the corporation adopted June 21, 1991 authorizing and directing such amendment as authorized by Section 30-146 and Section 30-147 of the Idaho Code.

Article Fifth is hereby amended to read as follows:

"FIFTH

The total authorized number of shares is 3,000 having no par value. The stock of the corporation is of but one class: Common. Shares are nonassessable by or on behalf of the corporation."

All provisions of the original Articles not herein modified remained unchanged. This amendment shall be effective upon acceptance for filing by the Office of the Secretary of State for Idaho.

These Articles of Amendment are executed pursuant to a resolution of the corporation adopted by the shareholders and directors unanimously approved by the holders of all six hundred (600) outstanding shares of common stock of the corporation, said shares being the only class of stock of the corporation.


