was filed in the office of the Secretary of State on the forty-nime and of October A.D. One Thousand Nine Hundred and is duly recorded on Film No. 25 of Record of Domestic Corporations of the State of Idaho, and that the said articles contain the statement of facts required by Sections 20, 20, 210101 and 2102, Idaho Code, Annotated.

AND I FURTHER CERTIFY, That the persons executing the articles and their associates and successors are hereby constituted a corporation, by the name stated in the articles, and for perpetual existence from the date hereof, with its registered office in this State located at lewiston in the County of name as such are subject to the rights, privileges and limitations granted to Religious, Ex-Service Men, Benevolent, Charitable and Fraternal Corporations, as provided in Chapter 11, Title 29, Idaho Code, Annotated.

## ARTICLES OF INCORPORATION OF NEZ PERCE AERIE NO. 631, FRATERNAL ORDER OF EAGLES, INC.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being the duly elected and installed officers of Nez Perce Aerie No. 631 of Lewiston, Idaho, Fraternal Order of Eagles, elected, qualified and installed pursuant to the custom of such organization, do hereby certify that pursuant to a resolution duly adopted by said Nez Perce Aerie No. 631 of Lewiston, Idaho, Fraternal Order of Eagles, (the same being a subordinate Aerie of the Grand Aerie of the Fraternal Order of Eagles), at a regular meeting of said Aerie held in Lewiston, County of Nez Perce, State of Idaho, on the 12th day of August, 1949, after all of the members of said Aerie had been given two weeks notice of said meeting by mailing and publication, that the question of the incorporation of said Aerie would be considered at said meeting, that all of the members present at such meeting being and constituting a quorum of the membership, pursuant to the custom thereof. voted in favor of said incorporation of said Nez Perce Aerie No. 631, under and by virtue of the laws of the State of Idaho, and in particular with the provisions of Chapter 11, Title 30, Idaho Code, and we, the undersigned officers, do hereby further certify:

FIRST: That the name of this corporation shall be Nez Perce Aerie No. 631, FRATERNAL ORDER OF EAGLES. INC."

SECOND: That said Aerie was duly and properly instituted under a dispensation received from the then Grand Worthy President of the Fraternal Order of Eagles, and received a Charter from the Grand Aerie of the Fraternal Order of Eagles, pursuant to its enactments, on the 26th day of February, 1904.

THIRD: That the purposes for which said corporation is formed are:

- To act and function as a Subordinate Aerie (a) of the Fraternal Order of Eagles, and this corporation shall have power to sue and be sued by its Corporate name, and in such name to acquire or receive by purchase, gift, grant, devise, or bequest, any property, real, personal or mixed, and the same to hold, sell, transfer, mortgage, convey, loan, let or otherwise use in accordance with the laws and usages of said Aerie and of the Grand Aerie of the Fraternal Order of Eagles, and not in conflict with the Laws of the State of Idaho, (except that said corporation shall have no power to divert any gift, grant or bequest from the special purposes designated by the donor), and in general to do all such other acts and things authorized by law, and as may be useful and necessary for the carrying on of the fraternal, beneficial and social purposes of the Fraternal Order of Eagles.
- (b) The several clauses contained in this statement of purposes shall be construed as both purposes and powers, and the statements contained in each clause shall be in no wise limited or restricted, by reference to, or inference from, the terms of any other clause, but shall be regarded as independent purposes and powers; and no recitation, expression or declaration or specific or special powers or purposes herein enumerated shall be deemed to be exclusive; but it is hereby expressly declared that all other lawful powers not inconsistent herewith are hereby included.

FOURTH: The duration of this corporation shall be perpetual.

FIFTH: The location and post office address of the AULW. HYATT registered office of this corporation in the State of Idaho WEISGERREE EQUIDING

shall be: EAGLE HALL, LEWISTON, NEZ PERCE COUNTY, IDAHO, which said place shall be the principal office for the transaction of the business of this corporation.

SIXTH: The officers of this corporation shall be the Junior Past Worthy President, Worthy President, Worthy Vice President, Worthy Chaplain, Secretary, Treasurer, Worthy not less than Conductor, Inside Guard, Outside Guard, and a Board of/three elected Trustees.

SEVENTH: This corporation shall not be a stock company and shall issue no shares of stock or stock certificates and that this corporation is not organized for the purpose of pecuniary profit.

EIGHTH: Membership in this corporation shall be limited and confined to the members in good standing now and at all times hereafter, in said Nez Perce Aerie No. 631, and shall be subject to all rules, regulations, requirements and By-laws of the said Aerie, and to the laws, rules and regulations of the Grand Aerie of the Fraternal Order of Eagles insofar as they are applicable and not in conflict with the statutes of the State of Idaho.

NINTH: Neither membership, nor any rights incidental to membership, in the corporation shall be transferable. All property rights of said corporation shall be vested in and be held by said Nez Perce Aerie No. 631, of the Fraternal Order of Eagles, Inc., in accordance with the Laws of the Fraternity.

TENTH: The meetings of this corporation shall be held in accordance with the By-laws of said Nez Perce Aerie No. 631, and a quorum provided by the laws of the Fraternal Order of Eagles shall constitute a quorum of this corporation.

ELEVENTH: The seal of said Nez Perce Aerie No. 631,

TWELFTH: Title to the assets of this corporation shall pass to the Grand Aerie of the Fraternal Order of Eagles, upon the dissolution of this corporation, or upon the revocation or surrender of the charter issued to it as a subordinate Aerie, by the Grand Aerie, Fraternal Order of Eagles.

THIRTEENTH: Real Estate shall not be purchased, acquired, sold or mortgaged, nor shall permanent improvements be made to real estate by this corporation except upon the recommendation of the Board of Grand Trustees, and the approval of the Grand Worthy President, in the manner provided by the laws of the Fraternal Order of Eagles.

FOURTEENTH: That the officers of this corporation heretofore and on April 1, 1949 elected in accordance with the custom of said organization and who shall hold office for the first year thereof to and to the first Friday of June, 1950, and until the selection and qualification of their successors are as follows:
