

Designation of Agent, and Acceptance of the Provisions of the Constitution of the State of Idaho.

Know All Men by These Presents:


That THE CONTINENTAL BUILDING & LOAN SAVINGS ASSOCIATION
a Corporation organized and existing under the laws of the State of
Colorado having filed in the office of the Secretary
of State of the State of Idaho a duly authenticated copy of its articles of In-
corporation, does hereby, in pursuance of the laws of the State of Idaho, make

desiring and intending to conform in all respects to the Constitution and laws
of said State, and to avail itself of the rights, privileges and immunities guar-
anteed by said Constitution and laws, does hereby accept the provisions of the
Constitution of the State of Idaho for all the intents and purposes contemplated
by the provisions thereof, relating to such acceptance by other than municipal
corporations. (Article XI, Section 7, Constitution of Idaho).
