



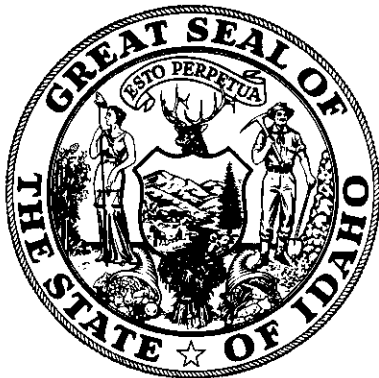
CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION
of
TYPE ETC. INC.

Know All Men By These Presents: That the undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

I

The name of the corporation shall be Type Etc. Inc.

II

The term for which said corporation shall exist shall be in perpetuity.

III

The address of the initial registered office of this corporation in the state of Idaho shall be 5657 Latigo Dr., Boise, Idaho 83709, and the name of the initial registered agent at that address shall be Philip A. Satterfield.

IV

The purposes for which this corporation is organized shall be and are:

1. To operate a typesetting, layout, pasteup and camera business.
2. To carry on any business which the corporation may deem proper or convenient to promote the interests of the corporation.
3. To borrow money at such rates of interest as the corporation may determine.
4. To conduct its business, carry on its operations and have offices and exercise the powers granted by these articles within or without this state.
5. To elect or appoint officers of the corporation and define their duties and fix their compensation.
6. To make and alter bylaws for the regulation of the affairs of the corporation.

7. To establish profit sharing plans, stock bonus plans and other incentive plans for all its officers and directors.
8. To have and exercise all powers necessary to effect its purposes.
9. To conduct its business and exercise all or any of its powers in the state of Idaho, or in any other state.
10. The corporation shall have the power to do all and everything necessary, suitable, convenient or proper to do all and everything necessary, suitable, or proper for the accomplishment of any one or more of its purposes.

V

The business of this corporation shall be managed and conducted by a board of directors. The number of directors shall be two. The names and addresses of the persons to serve as directors are:

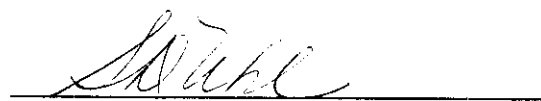
