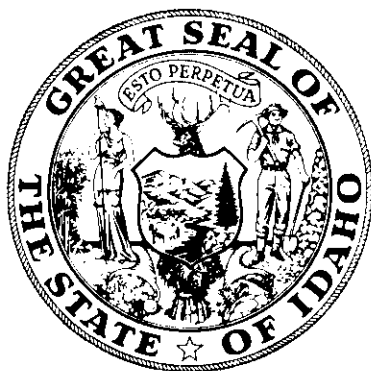

ARTICLES OF INCORPORATION
OF
"CALL ME" CEDAR SALES, INC.

KNOW ALL MEN BY THESE PRESENTS, that KELLE R. WEIKEL, the undersigned, a full age citizen of the United States, this day, for the purpose of forming a corporation under and pursuant to the laws of the State of Idaho, does hereby certify:

ARTICLE I.

That the name of the Corporation shall be "CALL ME" CEDAR SALES, INC.

ARTICLE II.

The purposes for which the Corporation is organized shall be, and include, the transaction of any and all lawful business for which a corporation may be incorporated under "The Idaho Business Corporation Act", State of Idaho.

ARTICLE III.

This Corporation shall have perpetual existence.

ARTICLE IV.

The location and post office address of the registered office in this State and principal place of business shall be 200 North Fourth Street, P. O. Box 1577, Coeur d'Alene, Idaho 83814; and the initial registered agent at such address is DICK ANDERSEN.

ARTICLE V.

There shall be only one class of capital stock of this Corporation, which shall be designated as common stock, and such common stock shall be and consist of FIFTY THOUSAND (50,000) shares each with a par value of One and no/100 Dollars (\$1.00) per share, totaling in the aggregate sum of FIFTY THOUSAND and no/100 DOLLARS (\$50,000.00).

ARTICLE VI.

The number of Directors constituting the initial Board of Directors of the Corporation is one (1). The number of Directors and Officers may from time to time be fixed by the By-Laws of the Corporation at any number.

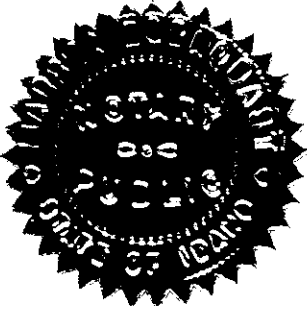
ARTICLE VII.
