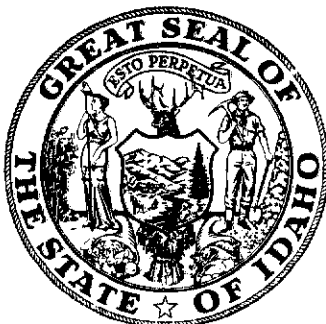

ARTICLES OF INCORPORATION OF

SEVEN A CABINETS, INC. 97 MAY 12 AM 9:27

The undersigned, acting as incorporator of a corporation under the Idaho Business Corporation Act, adopts the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is SEVEN A CABINETS, INC..

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are: the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

FOURTH: The aggregate number of shares which the corporation shall have authority to issue is 1,000 shares of one class of common stock. The par value of said stock shall be \$100.00 per share.
