## AN ACT

To Change the Name of the State Street Safe Deposit and Trust Company.

*Be it enacted by the Senate and House of Representatives in General Court assembled,  
and by the authority of the same, as follows:*

SECTION 1. The name of the State Street Safe Deposit and Trust Company, incorporated by chapter one hundred and ninety-nine of the acts of the year eighteen hundred and ninety-one, is hereby changed to the STATE STREET TRUST COMPANY.

Section 2. This act shall take effect upon its passage.

## AN ACT

to incorporate the State Street Safe Deposit and Trust Company.

*Be it enacted by the Senate and House of Representatives in General Court assembled, and by the authority of the same, as follows:*

SECTION 1. Royal E. Robbins, Benjamin F. Stevens, Edward Atkinson, Charles A. Welch, Benjamin F. Brown, Thomas O. Richardson, William L. Chase, Jerome Jones, George E. Keith, Otis E. Weld, Joseph B. Russell, Henry B. Endicott, Charles E. Sampson, Francis B. Sears, Frederick S. Davis and Moses Williams, their associates and successors, are hereby made a corporation by the name of the STATE STREET SAFE DEPOSIT and TRUST COMPANY, with authority to establish and maintain a safe deposit, loan and trust company in the city of Boston; with all the powers and privileges and subject to all the duties, liabilities and restrictions which now are or may hereafter be in force relating to such corporations.

Section 2. This act shall take effect upon its passage.
