Hale, John Aljets and the Clerk. The following proceedings were had to In the matter of creating the Village of Chubbuck

After taking the matter under advisement in regard to the petitions discussed by Attorneys Black & Black and Milton E. Zener on December 5th, as to the Incorporation of Chubbuck, it was the unanimous vote of the Board that the Petition represented by Black & Black he rejected and the Petition Represented by Milton E. It is, therefore, the further order of the Board that the following Order of In

corporation be spread on the minutes creating the Village of Chubbuck:

IN THE MATTER OF THE INCORPORATION OF THE VILLAGE OF CHUBBUCK.

ORDER OF INCORPORATION

WHEREAS, there has heretofore been filed with and presented to the Board of Count Commissioners of Bannock County. Idaho, a Petition signed by more than a majority of taxable inhabitants of the real property described in the Petition, and wherein said petitioners pray that they be incorporated as a village under the laws of the State of Idaho, and in which Petition they designate the name of "CHUBBUCK" as the name they wish to assume which Petition was attached a plat or map showing the boundaries of the proposed wiffere and

WHEREAS, it appears to the Board that there are more than one hundred twenty-five (125) actual residents residing within the territory described in said Petition, and that more than a majority of the taxable inhabitants of the said territory therein described signed said Petition, and that said Petition is in all respects true and correct and in full compliance with the statutory requirements; and

WHEREAS, it appears that the prayer of the said Petition should and ought to be granted.

NOW, THEREFORE, IT IS HEREBY, ORDERED, That there be, and there is hereby created, established and incorporated a village within the County of Bannock, State of Idamo, which is comprised of territory lying and being situate within said county, and which is more particularly described by metes and bounds as follows, to-wit:

Commencing at the S¹/₄ corner of section 3, T-6S.,R-34E.,B.M., thence S-39° 33'-E, along south line of said section 3, 1357.0 feet to the intersection with the E 1/16 line, thence S-0°09' E along E 1/16 line of section 10, 25.00 feet to the intersection with the south right-of-way of Chubbuck Road, the naint of hoginains, thence section is a section of the line. 25.00 feet to the intersection with the south right-of-way of Chubbuck Road the point of beginning, thence continuing S-0°09' E along said E 1/10 line, 1985.3 feet, thence N 89°21' W, 1372.9 feet to the intersection with the west right-of-way of the Yellowstone Highway, thence S0°05' W along said right-of-way 601.0 feet to the intersection with the latitudinal center line of said section 10, thence N 89°23' W along said center line, 1307.3 feet to the intersection with the W 1/10 line of said section 10, thence N 0°02' W along said W 1/16 line 1970.0 ft. to the intersection with "Stuart Lateral", thence N 42°00' W along said lateral 650 feet to the intersection with the South right-of-way of Chubbuck Road, thence S89°29' E along said right-of-way 575.0 feet to the intersection with the W 1/16 line of said section 10, thence N 0°30' W along said W 1/16 line, 3351.0 feet, thence S 89°29' E, 1290.0 feet to the intersection with the West right-of-way of the Yellowstone Highway, thence S 0°36' E along said feet, thence S 89°29' E, 1290.0 feet to the intersection with the West right-of-way of the Yellowstone Highway, thence S 0°36' E along said right-of-way 660.0 feet to the intersection with the latitudinal center line of Section 3, thence S 89°29' E along said center line 1627.0 feet to the intersection with the West right-of-way of 0.S.L.R.R., thence S 1°08' E along said right-of way 1131.6 feet, thence S 88°52' W 50.0 feet, thence S 1°08' E, 1525.0 feet to the intersection with the South right-of-way of Chubbuck Road, thence N 89°33' W, 236.0 feet more or less to the point of beginning.

IT IS FURTHER ORDERED, That the name by which said village shall be known and designated is, and shall be, "CHUBBUCK", and that said Village of Chubbuck, from the date hereof, shall have all of the rights, powers and immunities provided by the laws of the State of Idaho, and shall be governed by the provisions of said law applicable to the

IT IS FURTHER ORDERED, that J. O. Cotant, W. R. Ward, E. A. Stuart, John Valenty and Enoch Cox, all being persons possessing the qualifications as required by law, be; and they are hereby, appointed as Trustees of said Village of Chubbuck, Idaho, to hold office intil their successors are elected and qualified, in the time, manner and form prescribed by the statutes of the State of Idaho.
