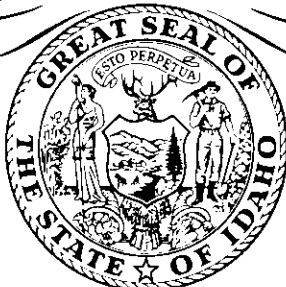

ARTICLES OF AMENDMENT
TO THE
ARTICLES OF INCORPORATION
OF
IDAHOP, INC.

IDAHOP, INC., an Idaho corporation, being desirous of changing its name to GOODING FARMS, INC., does hereby make and execute these Articles of Amendment to its Articles of Incorporation as follows:

I.

That the name of this corporation is "IDAHOP, INC.".

II.

Paragraph "FIRST:" of the original Articles of Incorporation of this corporation shall be and hereby is amended to read and provide as follows:

"FIRST: the name of this corporation is "GOODING FARMS, INC."."

III.

This amendment was adopted by all of the shareholders of the corporation consenting thereto in writing on the date of January 2, 1973 and by a resolution of the Board of Directors authorizing such amendment adopted on the date of January 2, 1973 at a meeting duly and regularly called for that purpose at which all of the directors of the corporation were personally present and voted for such resolution.

IV.

This amendment shall not affect the capital stock or state of capital of this corporation and is intended to accomplish only a change of the name of this corporation.
