KNOW ALL MEN BY THESE PRESENTS: REG'D. NO. 22
SEC. OF STATE
WE, the undersigned, do hereby form a profit corporation,
Chapter 1, Title 30 of the Idaho Code, and do hereby certify
and declare:

ARTICLE I: NAME The name of this organization shall be the
WILKINS AGRICULTURE, INC.

ARTICLE II: PROFIT, EXISTENCE This corporation is
organized as a profit corporation of the State of Idaho, and its
length of existence shall be perpetual.

ARTICLE III: PURPOSE The purposes of this corporation are
to promote, conduct, provide for and carry on any and all
activities in connection with the business and operation of a
farming and ranching enterprise.

The Corporation shall have the power to do anything not
prohibited by law necessary or requisite for the furthering of
the purposes of this corporation.


