ARTICLES OF INCORPORATION

OF

GOLDEN MAPLE MINING AND LEACHING COMPANY, INC.

PURSUANT TO MONTANA BUSINESS CORPORTION ACT

The undersigned, acting as incorporators of a corporation under the Montana Business Corporation Act, adopted the following Articles of Incorporation:

Ι.

That the name of this corporation is and shall be GOLDEN MAPLE MINING AND LEACHING COMPANY, INC.

II.

This corporation is formed under the Montana Business Corporation Act to engage in the general mining business, and in each and every phase or part thereof, and in all other businesses lawful under said Act necessary or covenient to such general mining business and for such purpose or purposes shall have each and every power, without limitation, granted corporations by said Act.

III.

The term for which this corporation is to exist is perpetual.

IV.

The address of the registered office of the corporation is 1004 South California, Butte, Montana 59701, and LAURA A. NALL is its registered agent at such office.

The address of the administrative office of the corporation is Sunshine Star Route, Kellogg, Idaho 83837, c/o Donald C. Long.

V.

That the amount of capital stock of this corporation shall be SIXTY THOUSAND DOLLARS (\$60,000.00) divided into SIX MILLION SHARES (6,000,000) of the par value of One Cent each.

VI.

- The capital stock of this corporation shall be common stock, which will be fully paid when issued and nonassessable.
 - (b) No preemptive or conversion right shall exist.

The Board of Directors shall have the power to adopt, alter, amend, or repeal the By-Laws of the corporation.

Х.

The Director or officer of the corporation shall not, in the absence of actual fraud, be disqualified by his office from dealing or contracting with the corporation, either as vendor, purchaser, or otherwise; and in the absence of actual fraud no transaction or contract of the corporation shall be void or voidable by reason of the fact that any director or officer, or firm of which any director or officer is a member, or any other corporation of which any director or officer is a shareholder, officer or director, is in any way interested in such transaction or contract; provided, that such transaction or contract is, or shall be authorized, ratified or approved (1) by a vote of a majority of a quorum of the Board of Directors, or of the Executive Committee, if any, counting for the purpose of determining the existence of such majority or quorum, any Director, when present, who is so interested, or who is a member of a firm who is interested; or (2) at a stockholders meeting by a vote of a majority of the outstanding shares of stock of the corporation represented at such meeting and then entitled to vote, or by writing or writings signed by a majority of such holders of stock which shall have the same force and effect as though such authorization, ratification or approval were made by the stockholders; and no director or officer

shall be liable to account to the corporation for any profits realized by him through any such transaction or contract of the corporation authorized, ratified or approved, as aforesaid, by reason of the fact that he may be, or any firm of which he is a member, or any corporation of which he is a shareholder, officer or director, was interested in such transaction. Nothing in this paragraph contained shall create any liability in the events above mentioned, or prevent the authorization, ratification or approval of such contracts or transaction in any other manner than permitted by law, or invalidate or made voidable any contract or transaction which would be valid without reference to the provisions of this paragraph.

ARTICLES OF INCORPORATION

the Shareholders of the Golden Maple Mining and Leaching Company, Inc., a Montana corporation, held at Wallace, Idaho, on the 19th day of February 1983, specifically called for the purpose of acting upon a proposal to amend the Articles of Incorporation to increase the capitalization to \$100,000.00 divided into 10,000,000 shares of a par value of One Cent (\$.01) each, it was decided by a favorable vote of more than two-thirds of all the issued and outstanding stock of said corporation upon a resolution duly made, seconded and adopted that the Articles of Incorporation be amended as follows:

That Article V be amended to read as follows:

ARTICLE V.

That the amount of capital stock of this corporation shall be ONE HUNDRED THOUSAND DOLLARS (\$100,000.00) divided into TEN MILLION SHARES (10,000,000) of the par value of ONE CENT each.

There were 1,401,650 common shares outstanding at the time of said meeting all of which were entitled to vote.

1,365,880 shares were represented at said meeting all of which were voted in favor of the amendment.
