We, the undersigned, as proper persons acting as incorporators of a corporation under the laws of the state of Idaho, adopt the following articles of incorporation:

FIRST The name of the corporation is: Jaclyn's Interior Design, Inc.

THIRD The Purpose of the corporation is: This corporation may engage in or transact any and all lawful activities or business permitted under the laws of the United States, the State of Idaho, or any other state, county, territory, or nation.

FOURTH The aggregate number of authorized shares is: 100,000 at \$1.00

FIFTH The corporation will not commence business until at least \$1000 have been received by it as consideration for the issuance of shares.

SIXTH Cumulative voting of shares of stock is authorized.
