KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, acting as incorporators of a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST

The name of the corporation is THOMPSON AUTO REPAIR INC.

SECOND

The period of its duration is perpetual.

THIRD

The purpose or purposes for which the corporation is organized are:

- To carry on a general vehicle repair business; to sell and distribute auto and truck parts and accessories; to maintain a service and repair department for motor vehicles; and to do whatever may be necessary and convenient to carry on the business and to accomplish such objectives as may be incident to the business; and
- 2. To transact all other lawful business for which corporations may be incorporated under the Idaho Business Corporations Act.

FOURTH

The aggregate number of shares which the corporation shall have authority to issue is ten thousand (10,000) shares of \$1.00 par value common stock.

FIFTH

Shareholders shall have full pre-emptive rights.

SIXTH

Provisions for the regulation of the internal affairs of the corporation are such as may be provided by the By-Laws of the corporation, including provision for restriction on transfer of shares, as provided in Idaho Business Corporation Act, Section 30-1-23A. IDAHO SECRETARY OF STATE
