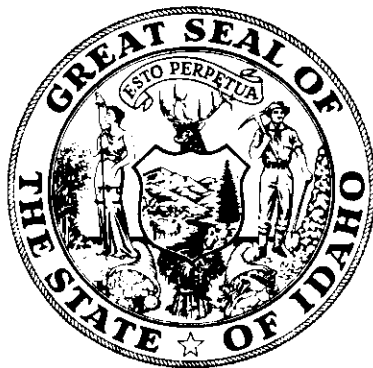

SUBJECT: AMENDMENT TO ARTICLES OF INC. OF THE IDAHO GOLF ASSOCIATION, INC.

Dear Mr. Secretary:

This is to advise that the IDAHO GOLF ASSOCIATION, INC., at the Annual Meeting of the General Membership held at the Rupert Country Club, Rupert, Idaho, on October 8, 1983, did vote in favor of adopting the following amendment to Article XIII of the Idaho Golf Association Articles of Incorporation in accordance with the roll call vote, copy of roll call enclosed herewith. Prior to the roll call vote, a roll call of the member clubs present with three (3) authorized voting delegates each, showed twenty-two (22) member clubs present, which number established a quorum of said association.

ARTICLE XIII, IDAHO GOLF ASSOCIATION, INC., as adopted October 8, 1983:

"All General and Special Meetings of the members of this Corporation shall be held pursuant to notice of the time and place provided to the membership by publication of same in any newspaper of general circulation in the community in which the principal office of the Corporation is located. After notice has been so given, ten percent (10%) of the voting members entitled to vote who are present at such meeting shall constitute a quorum for the transaction of the business of this Corporation. There shall be at least one general membership meeting each year to be held at such time and place as the Board of Directors may select."
