Pursuant to Section 30-1-124 of the Idaho General Business Corporation Act, PIN-NIP, INC. and D-I-1-4, INC. hereby make the following corrections:

1. The document to be corrected is the "Certificate And Articles of Merger of Domestic and Foreign Corporations" filed on January 13, 2005 at 2:30 p.m., a copy of which is attached to these Articles of Correction.

2. The document contains an inaccuracy in Paragraph 4(d) to wit: the document states that the corporations shall file "separate" state and federal income tax returns through December 31, 2004 when it should have stated that the corporations shall file "consolidated" state and federal income tax returns.

3. The corrected Paragraph 4(d) shall now read:

The proposed merger will become effective at 11:59 P.M., December 31, 2004. The merging corporation and the surviving corporation shall file consolidated state and federal income tax returns through December 31, 2004, and the surviving corporation, D-I-1-4, INC., will operate the businesses of the merging corporation and the surviving corporation commencing with January 1, 2005, and file tax returns involving all such operations.

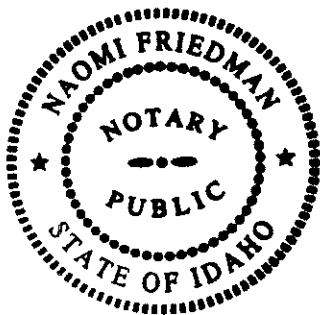
