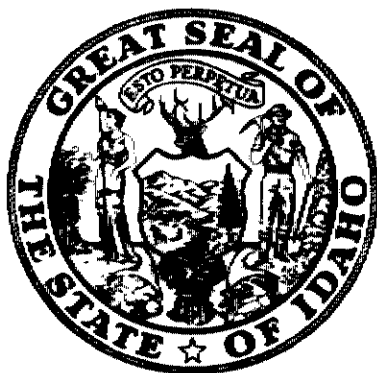

ARTICLES OF AMENDMENT

Pursuant to the provisions of Section 30-327, Idaho Code, Emerald Park Townhome Association, Inc., has adopted the following Articles of Amendment to its Articles of Incorporation:

I

The name of the corporation is Emerald Park Townhome Association, Inc.

II

The following amendment to the Articles of Incorporation was adopted by a consent in writing signed by all members entitled to vote with respect thereto:

RESOLVED, that the Articles of Incorporation of the corporation be amended by deleting the last three lines of Article IV paragraph 1 and inserting the following language in its place:

and to promote the health, safety and welfare of the residents within the above described property. The Declarant has an interest in the larger parcel of property referred to herein as the "Development Property." Declarant intends to develop portions of the Development Property in one or more additional phases. The development of such additional phases will generally be of similar kind, quality, style, size and costs as the development of the real property legally described above. The persons obtaining lots in such additional phases shall have the right to participate in and enjoy the

Common Area described in the Declaration and the Owner shall have the right to participate in and enjoy the Common Area of the Property and such additional areas. This Association is formed for the following purposes:
