ARTICLES OF INCORPORATION

JUMP CREEK RANCHES WATER USERS' ASSOCIATION, INC.

In compliance with the requirements of the law of Idaho relating to nonprofit corporations and acts amendatory and supplemental thereto, including particularly Title 30, Chapter 3, Idaho Code, the undersigned natural person, being of full age and a resident of the United States, in order to form a nonprofit corporation for the purpose hereinafter stated, does hereby as incorporator, adopt the following Articles of Incorporation and certify:

ARTICLE I

NAME OF CORPORATION

The name of the corporation is **JUMP CREEK RANCHES WATER USERS' ASSOCIATION, INC.**

ARTICLE II

DURATION OF CORPORATION

The duration of the corporation shall be perpetual.

ARTICLE III

NON-PROFIT STATUS

This corporation shall be a nonprofit corporation. This Association is organized on a nonprofit basis for the mutual benefit of its members and consequently will not have profits from which to pay dividends on its capital.

ARTICLE IV

REGISTERED OFFICE AND AGENT

The address of the initial registered office located in Owyhee County, Idaho shall be **Route #1 Box # 315, Marsing, Idaho 83639**. The name of the initial registered agent shall be **Jessie Bridger** at the aforementioned address.

ARTICLE V

PURPOSE OF CORPORATION

The purpose of this non-profit corporation is to install, maintain, and repair all necessary water systems to deliver water from the Gem Irrigation District South Board of Control 28.5 lateral ditch for the mutual use of the members.

This corporation is organized for the purpose of providing and conveying irrigation water to the members of the association who are entitled thereto; also to maintain, repair, install, and construct pipes, mainlines, pumping equipment and irrigation of this association.

To buy, hold and exercise all privileges of ownership in and to the real and personal property (including easements and rights-of-way) as may be necessary or convenient for the conduct and operation of the business of the Association or incidental thereto. The Association must own the system. No lease arrangement is acceptable.

The bylaws set forth by the Association will regulate the internal affairs of the corporation.

ARTICLE VI

MEMBERSHIP

Membership of this corporation consists of anyone who uses the water systems of the corporation, to include but not limited to, mainlines, pipelines, pumps, and utilities of the corporation. Membership in the Corporation shall be governed and regulated by the Bylaws of the Corporation. Each member shall have voting privileges equal to one vote for each inch of water, which such member is entitled to receive. No officer, director, or member of the corporation shall be personally liable for the debts, liabilities or obligations of the corporation.

ARTICLE VII

ASSESSMENTS

The corporation may levy assessments upon its members in proportion to the water that the member is entitled to receive. No member shall be entitled to demand or receive water until such assessments are paid. In case any assessment, as herein provided for is due and unpaid the association may sue to collect the same, in the name of its secretary-treasurer as such, in any Court of competent jurisdiction, and in addition to the amount due including all penalties and interest, and all costs incurred in said action, may collect a reasonable attorney's fee in such action to be fixed by the court.

ARTICLE VIII

BOARD OF DIRECTORS

The Board of Directors for this corporation shall have Four (4) Officers with the titles of Chairman, Vice Chairman, Secretary and Treasurer. Annually a majority of members shall duly elect each of the officers.

ARTICLE IX

DISSOLUTION

Upon dissolution of the corporation, the Board of Directors shall, after paying or making provision for the payment of all liabilities of the corporation, distribute all the assets of the Corporation consistent with the purposes of the Corporation. Any such assets not so distributed shall be distributed by the district court of the county in which the principle office of the Corporation is then located, exclusively for such purposes or to such organizations, as such court shall determine to be consistent with the purposes of the Corporation.

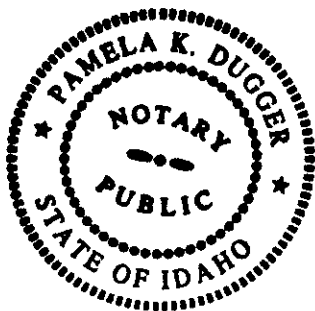
