## ARTICLES OF INCORPORATION OF WESTBANK LEASING CORPORATION

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all of whom are natural persons of full age and are citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and we do hereby certify:

Ι

That the name of this corporation shall be WESTBANK LEASING CORPORATION

II

That the purposes for which this corporation is formed are:

- 1. To engage in the business of conducting and operating motels, hotels, restaurants, cafes, taverns and any other business which can be conveniently carried on in connection therewith.
- 2. To purchase or otherwise acquire, and to hold, own, maintain, work, develop, sell, lease, exchange, hire, convey, mortgage or otherwise dispose of and deal in, lands and leaseholds, and any interests, estate and rights in real property, and any personal or mixed property, and any franchises, rights, licenses or privileges necessary, convenient or appropriate for any of the purposes herein expressed.
- 3. To borrow money, and to make and issue notes, bonds, debentures, obligations and evidences of indebtedness of all kinds, whether secured by mortgage, pledge or otherwise, without limit as to amount, and to secure the same by mortgage, pledge or otherwise, and generally to make and perform agreements and contracts of every kind and description.
- 4. To carry on any other lawful business whatsoever which may seem to the corporation capable of being carried on in connection with the above, or calculated, directly or indirectly, to promote the interest of the corporation or to enhance the valuation of its property.

III

Subject to the dissolution in the manner provided by law, the duration of this corporation shall be perpetual.

ΙV

That the principal place of business, registered office and the location and postoffice address of the registered office of said corpora-

tion shall be Idaho Falls, County of Bonneville, State of Idaho.

V

That the total autorized capital stock of said corporation shall be TWENTY-FIVE THOUSAND AND NO/100 (\$25,000.00) DOLLARS, divided into Two Hundred Fifty (250) shares of the par value of ONE HUNDRED AND NO/100 (\$100.00) DOLLARS each, and all of said capital stock shall be common stock, and shall be non-assessable.

VI

The number of directors of said corporation shall be three (3), to be elected annually.

VII

The Board of Directors shall have the power to repeal and amend the By-Laws of the corporation and adopt new By-Laws at any meeting of the Board of Directors. All By-Laws shall be subject to amendment, alteration and repeal by the stockholders at any annual meeting or at any special meeting called for such purpose.
