


**CERTIFICATE OF INCORPORATION

ARTICLES OF INCORPORATION

WE, THE UNDERSIGNED, HEREBY ASSOCIATE OURSELVES WITH THE OBJECT OF FORMING A CORPORATION UNDER THE LAWS OF THE STATE OF IDAHO, AND CERTIFY AS FOLLOWS:

- 1) THE NAME OF THIS CORPORATION SHALL BE:
S. R. O. CONSTRUCTION, INC.
- 2) THE BUSINESS IN WHICH THIS CORPORATION SHALL BE ENGAGED IS GENERAL CONTRACTING AND REMODEL CONSTRUCTION.
- 3) TO CONDUCT ITS BUSINESS, THIS CORPORATION SHALL BE ENDOWED WITH THE FOLLOWING POWERS:
 - A) TO BORROW MONEY AS NECESSARY FOR OPERATIONS,
 - B) TO CONTRACT, BE A PARTNER IN BUSINESS VENTURES, TO ACQUIRE AND DEAL IN ITS OWN STOCK, SHOULD THE NECESSITY ARISE,
 - C) TO ACQUIRE OTHER BUSINESSES, EITHER BY PURCHASE WITH CASH, SECURITIES, NOTES, OR OTHER ASSETS, OR THROUGH MERGER OR OTHER COMBINATION,
 - D) TO DEAL IN, PURCHASE, LEASE, OR SELL PERSONAL PROPERTY AND EQUIPMENT,
 - E) TO MORTGAGE, PURCHASE, LEASE, OR SELL, OR OTHERWISE DEAL IN REAL PROPERTY FOR ALL PURPOSES,
 - F) TO APPLY FOR OR PURCHASE PATENTS, TRADEMARKS, TRADENAMES, OR OTHER INTANGIBLE OBJECTS THAT MAY BE REQUIRED FOR THE ORDINARY CONDUCT OF BUSINESS,
 - G) TO CARRY ON ANY OTHER LAWFUL BUSINESS OR ENGAGE IN ANY OTHER ACTIVITY PERMISSIBLE UNDER THE LAWS OF THE STATE OF IDAHO.

4) THE CAPITAL STOCK THAT THIS CORPORATION SHALL BE AUTHORIZED TO ISSUE SHALL BE 500 SHARES OF THE PAR VALUE OF \$ 100 EACH, FOR A TOTAL AMOUNT OF \$50,000.

5) THIS CORPORATION SHALL HAVE PERPETUAL EXISTENCE, UNLESS DISSOLVED BY VOLUNTARY ACTION OF THE STOCKHOLDERS OR INVOLUNTARILY THROUGH DEFAULT.
