**Article I**

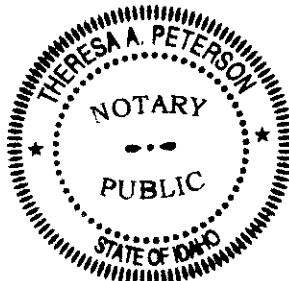
