CORPORATE NAME**

The name of this corporation shall be:

**ARTICLE II
EXISTENCE**

This corporation shall have perpetual existence.

**ARTICLE III
PURPOSES**


ARTICLE VII LIMITED LIABILITY

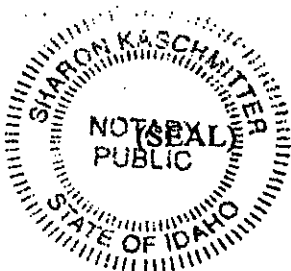
