ARTICLES OF INCORPORATION  
OF  
J & J OUTFITTERS, INC.

We, the undersigned, all being persons of legal age and citizens of the United States of America, do hereby, as incorporators thereof, form a corporation under the laws of the State of Idaho, and we do hereby adopt Articles of Incorporation of such Corporation as follows:

I.

The name of said Corporation is: J & J OUTFITTERS, INC.

II.

The duration of said Corporation shall be perpetual.

III.

The purpose of the Corporation is to engage in and promote the business of providing facilities and services for the conduct of outdoor recreational activities, including but not limited to fishing and float or power boating on Idaho rivers and streams, and to conduct and engage in all other businesses and activities not forbidden by law.

IV.

The shares of stock of said Corporation shall all be common stock and the aggregate number of shares which the Corporation shall have the authority to issue is one thousand (1,000) shares, all of which are to be without par value. Shares shall be issued for such consideration as may from time to time be

fixed by the Board of Directors of the Corporation without action by the shareholders. Said shares of stock shall be fully paid up before being issued and after issuance shall be nonassessable.

V.


