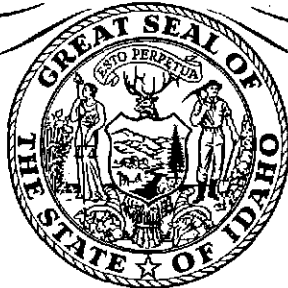

ARTICLES OF AMENDMENT OF ARTICLES OF INCORPORATION OF

KNOW ALL MEN BY THESE PRESENTS That at a regular meeting of the membership of El Korah Temple A. A. O. N. M. S. was held at 7:30 o'clock P.M. on Wednesday, November 11th, 1964 at the Mosque at 12th and Idaho Streets, Boise, Ada County, Idaho, that due and timely notice of the purpose and business of said meeting was given as required by the By-Laws and the laws of the State of Idaho; that the following amendment to the Articles of Incorporation of said Corporation was unanimously adopted:
