ARTICLES OF INCORPORATION 87 DEC 4 AM 10 00

The undersigned, acting as incorporator, in order to form a corporation for the purposes hereinafter stated, pursuant to the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation for such corporation.

ARTICLE I

The name of the corporation shall be CVP Trucking, Inc.

ARTICLE II

The corporation is to have perpetual existence.

ARTICLE III

The corporation is formed to transact any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

ARTICLE IV

The capital stock of the corporation shall be one hundred (100) shares of common stock, without par value. The capital stock of the corporation shall not be assessable.

ARTICLE V

ARTICLE VI
