

ARTICLES OF INCORPORATION
OF
HOPKINS-BUHL FUNERAL CHAPEL, INC.

The undersigned, acting as incorporators of a corporation under the Idaho Business Incorporation Act, adopt the following Articles of Incorporation for such corporation:

FIRST: The name of the corporation is:
HOPKINS-BUHL FUNERAL CHAPEL, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the corporation is organized are:

(a) To engage in undertaking, embalming, and directing of funerals, the building and maintenance of a funeral chapel, and the dealing in and selling of coffins and caskets, and all such property, goods, wares, and merchandise as are incidental to and used in the business of undertakers and morticians, and also the buying, owning, holding, selling, letting, leasing, and dealing in and with real and personal property of every kind and nature upon which or in connection with which the business of undertakers and morticians may be conducted, and also the owning and operating of motor vehicles and such other modes or vehicles of conveyance for hire, which motor vehicles or other conveyances now are or may be used in the ordinary course of the business of undertaking, embalming, and funeral directing.

(b) To carry on any other kind of business or business activities that the shareholders may from time to time deem to be advisable or proper in connection with a funeral home business.

1 (c) To purchase, lease, own, sell, mortgage, sub-lease,
2 and otherwise acquire lands, buildings, easements or property,
3 real and personal, which may be requisite for the purposes or are
4 capable of being conveniently used in connection with any of the
5 objects of this corporation, and to enter into, make, perform and
6 carry out contracts of every sort and kind with any person, and to
7 acquire and take over the good will, property, rights, franchises
8 and assets of every kind and the liabilities of any person, firm,
9 association, or corporation, either wholly or in part, and to pay
10 for the same in cash, stocks or bonds of the corporation, or
11 otherwise.

12 (d) In the purchase of or acquisition of property,
13 business rights or franchises or for any other object in and about
14 its business or affairs, to incur debt and to borrow and secure
15 the payment of money in any lawful manner including the issue and
16 sale or other disposition of bonds, debentures, notes and other
17 evidences of indebtedness.

18 (e) Without in any particular way limiting any of the
19 objects or purposes or powers of the corporation, the business or
20 purposes of the company shall be empowered from time to time to do
21 any one or more or all of the acts and things herein set forth and
22 to engage in the general funeral direction business, and all such
23 other acts, things and business in any way connected therewith or
24 auxillary thereto.

25 (f) To transact any and all lawful business for which
26 corporations may be incorporated under the Idaho Business Corpora-
27 tion Act.
