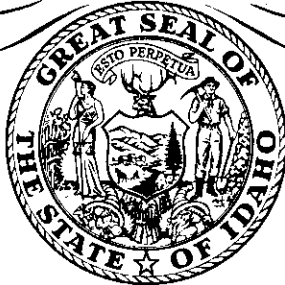

ARTICLES OF AMENDMENT
OF THE
SAGEBRUSH SHUFFLERS, INC.

KNOW ALL MEN BY THESE PRESENTS: That at a meeting of the members of Sagebrush Shufflers, Inc., a non-profit fraternal corporation organized pursuant to Chapter 10, Title 30, Idaho Code, held at the Sagebrush Shufflers Hall, Mountain Home, Elmore County, Idaho, on Saturday, the 19th day of June, 1965, at 8:30 o'clock P. M., notice of which meeting was published in the Mountain Home News, a newspaper published and circulated in the City of Mountain Home, Elmore County, Idaho, in four successive issues of said newspaper. The following Articles of Amendment were adopted by a majority of the quorum of members present at the said meeting:

ARTICLE I: The members of the Sagebrush Shufflers, Inc., at least two-thirds of whom are citizens of the United States of America, do associate together for the purpose of forming a non-profit fraternal corporation.

ARTICLE II: The purpose of the corporation as set forth in the original Articles of Incorporation are amended to read as follows:

1. To form a membership of persons in the spirit of fraternity, friendship and good fellowship to share the pleasures of square and round dancing.
2. To encourage cultural activities and to preserve the social and cultural heritage of the old west.
3. To encourage the active participation in civic and cultural betterment of the community.

4. To uphold the principles of good government.

5. To assist in every honorable way the furthering of the interests of its members towards bringing a better understanding among all men.

6. To teach that organization, cooperation and reciprocity are better than rivalry, strife and destructive competition.

7. To work together in brotherly union for the pursuit and accomplishment of the above-named purposes.

8. To acquire necessary real property, leaseholds, and personal property to be used exclusively, to carry out the functions, purposes and objectives heretofore listed.

ARTICLE III: The provision in the original Articles of Incorporation contained in the paragraph designated "Amendments" is hereby amended to read as follows:

Amendments to these Articles of Incorporation may be made in the manner and method as prescribed by the statutes of the State of Idaho.


