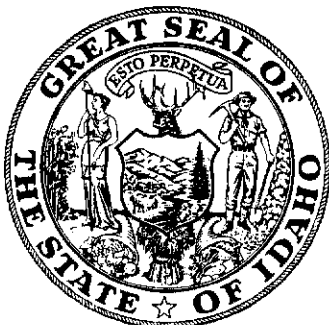

ARTICLES OF INCORPORATION

The undersigned, acting to incorporate a corporation under the Idaho Business Corporation Act, adopt the following Articles of Incorporation for such corporation:

1. **NAME:** The name of the corporation is V.I.P. MULTI SERVICES INCORPORATED.
2. **DURATION:** The period of its duration is perpetual.
3. **PURPOSES:** This corporation may transact any and all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.
4. **SHARES AUTHORIZED:** The aggregate number of shares which the corporation shall have authority to issue is ten thousand (10,000) shares at \$1.00 par value common stock.
5. **PREEMPTIVE RIGHTS:** Shareholders shall have preemptive rights to acquire unissued or treasury stock or securities convertible into or carrying a right to subscribe to or acquire shares.
6. **BUSINESS AFFAIRS:** Provisions for the regulation of the internal affairs of the corporation are such as may be provided in detail by the corporation's By-Laws, including restrictions on transfer of shares.


