# ARTICLE ONE

 $\underline{\text{Name}}$ . The name of the corporation is A & M SERVICE CENTER, INC.

#### ARTICLE TWO

<u>Purposes</u>. The purpose of the corporation is to engage in any and all lawful business for which corporations may be organized under the Idaho Business Corporation Act.

#### ARTICLE THREE

<u>Duration</u>. The period of duration of the corporation is perpetual.

### ARTICLE FOUR
