ARTICLES OF INCORPORATION

OF

SPORTSMAN'S SHANGRI-LA, INC.

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, all being of full age and citizens of the United States, have this day voluntarily associated ourselves together for the purpose of forming a corporation under the laws of the State of Idaho, and to that end do hereby adopt articles of incorporation as follows:

ARTICLE I

The name of the proposed corporation is SPORTSMAN'S SHANGRI-LA, INC.

ARTICLE II

The purposes of the corporation are to purchase, own, improve, equip, operate and manage a ranch or ranches and engage in any agricultural or husbandry pursuits to include but not exclusively, the promotion and development of hunting and fishing lodges, clubs and associations, specifically authorizing the subleasing, managing, operation, licensing or permissive use of any or all of the property so controlled, owned or managed in any organization whatsoever, profit or non-profit, with the further right, privilege and authorization to borrow, fund or expend monies for the promotion and development of the said property and all acts and undertakings pertinent, proper and necessary to the above not otherwise restricted by the laws of the State of Idaho or of the United States of America.

ARTICLE III

The duration of the corporation shall be a period of forty-five (45) years with the right and privilege of renewal and continuation of same in accordance with the laws of the State of Idaho.
