The undersigned, acting as incorporators under the provisions of the Idaho Corporation Act, adopts the following Articles of Incorporation.

ARTICLE I.

Name.

The name of this Corporation is Campbell Investment Consulting, Inc.

ARTICLE II.

Stock Clauses.

The aggregate number of shares which this Corporation shall have authority to issue is 100 common shares, no par value. The Corporation shall not have the authority to issue shares in series.

ARTICLE III.

Registered Office and Registered Agent.

Period of Duration.


The duration of this Corporation is to be perpetual.

ARTICLE VIII.


Amendment of Articles of Incorporation.
