- I, the undersigned roon, citizen of the State of Idaho, being of legal age and hence capable of contracting, hereby enter into an association to form a corporation under the laws of the State of Idaho and do hereby certify as follows:
- 1) The name of the corporation shall be Vauk Enterprises, Inc.
- 2) The general nature of the business conducted by this corporation shall be retail merchandising of welding equipment and related supplies and commodities.
- 3) In the conduct of this business, this corporation shall also have the following powers:
 - a) to enter into and perform contracts of any and all kinds, to become a partner in any lawful business venture, to acquire and deal in the stock of other corporations, or its own stock and security should the need arise,
 - b) to establish pension and profit sharing plans,
 - c) to acquire other businesses, either through purchases of assets or merger of corporate structures, or by the exchange of cash, stock, securities, or other consideration,
 - d) to borrow money as necessary and to the extent permissible by law,
 - e) to purchase, lease, or otherwise deal in personal property and dquipment as necessary to the conduct of business
