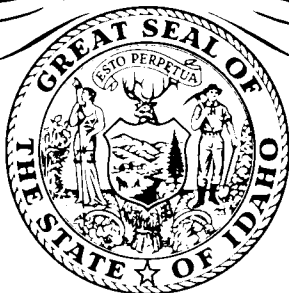

KNOW ALL MEN BY THESE PRESENTS:

That we, the undersigned, President and Secretary,
respectively, of IDAHO SOCIETY OF FARM AND RANCH MANAGERS AND
APPRAISERS, INC., do hereby certify as follows:

That IDAHO SOCIETY OF FARM AND RANCH MANAGERS AND APPRAISERS,
INC., is a corporation duly organized and existing under and by
virtue of the laws of the State of Idaho.

That a special meeting of the Board of Directors of IDAHO
SOCIETY OF FARM AND RANCH MANAGERS AND APPRAISERS, INC. was duly
held on the 3rd day of February, 1978, at 10:00 o'clock a.m.
in the City of Twin Falls, State of Idaho, at which meeting all
of the members of the Board of Directors of said corporation
were present; that at said meeting a resolution was regularly
proposed, voted upon and adopted by the unanimous vote of all
of said directors, amending the Articles of Incorporation of
said corporation; that the following is a full, true and
correct copy of the resolution of said Board of Directors
amending the Articles of Incorporation:

"BE IT RESOLVED that Article I of the
Articles of Incorporation of IDAHO
SOCIETY OF FARM AND RANCH MANAGERS AND
APPRAISERS, INC. be amended by amending
Article I so that it shall, as amended,
read as follows:

'ARTICLE I

The name of this association shall be
IDAHO SOCIETY OF FARM MANAGERS AND RURAL
APPRAISERS, INC.'"

That said resolution of the Board of Directors was approved
on the 3rd day of February, 1978, by the written consent
of those entitled to vote at the time said consent was
given; that the following is a full, true and correct copy
of said consent of said persons to the Articles of Incorporation:

"We, the undersigned, entitled to vote, hereby, and by these presents do, consent to, confirm and ratify, the amendment of the Articles of Incorporation made by the Board of Directors of IDAHO SOCIETY OF FARM AND RANCH MANAGERS AND APPRAISERS, INC. at a special meeting held on the 3rd day of Feb., 1978, at 10:00 o'clock a.m., which amendment is as follows, to-wit:

"BE IT RESOLVED that Article I of the Articles of Incorporation of IDAHO SOCIETY OF FARM AND RANCH MANAGERS AND APPRAISERS, INC. be amended by amending Article I so it shall, as amended, read as follows:

'ARTICLE I
