ARTICLES OF INCORPORATION

We, the undersigned natural persons of full age, all of whom are citizens of the United States, desiring to form a corporation under the Idaho Business Corporation Act, hereby adopt the following Articles of Incorporation:

I.

The name of the corporation is FirstDial Financial Services Idaho, Inc.

II.

The period of duration of the corporation shall be perpetual.

III.

The purpose for which the corporation is organized is the transaction of any or all lawful business for which corporations may be incorporated under the Idaho Business Corporation Act.

IV.

The total authorized number of par value shares is 100 shares of common stock of the par value of \$100.00 per share.

V.

As the corporation is one of the various subsidiaries affiliated with a parent corporation, it is contemplated that there will be relations between this corporation and its parent corporation, and associated companies and persons; therefore, no contract, act or other transaction between this corporation and any person or persons, co-partnership, corporation or association shall be affected or invalidated by the fact that any one or more of the shareholders, directors or officers of this corporation is interested in, or is a shareholder, director or officer of such other corporation or association, or is a party to or interested in such contract, act or other transaction, or in any way connected with such person or persons, co-partnership, association or corporation or that in any transaction between this corporation and another corporation either of them is a stockholder in the other. Any person who may become a director of this corporation is hereby relieved from all disability or liability arising out of any contract in good faith with the corporation for the benefit of himself or any person or persons, co-partnership, association or corporation in which he may have or represent a financial interest.
