The undersigned, acting as incorporator under the Idaho Nonprofit Corporation Act, adopt the following Articles of Incorporation for such nonprofit corporation:

FIRST: The name of the nonprofit corporation is LIVING WORD MISSIONARY BAPTIST CHURCH, INC.

SECOND: The period of its duration is perpetual.

THIRD: The purpose or purposes for which the nonprofit corporation is organized is to operate a Missionary Baptist Church in Lewiston, Idaho.

FOURTH: The address of the initial registered office of the nonprofit corporation is 707 Preston Avenue, Lewiston, Idaho 83501, and the name of its initial registered agent at such address is James D. Black.

FIFTH: This nonprofit corporation shall have members consisting of the congregation of the church.

SIXTH: The number of directors constituting the initial Board of Directors of the nonprofit corporation is three (3), and the names and addresses of the persons serving as directors are:

EIGHTH: In the event of dissolution of the nonprofit corporation, the assets will be distributed to the sponsoring church, Faith Missionary Baptist Church, located in Concord, California, to be used for continuing mission work in the Northwest.
