# ARTICLES OF INCORPORATION

OF

# LAMBERT PRODUCE CO.

KNOW ALL MEN BY THESE PRESENTS: That we, the undersigned, being natural persons of full age and citizens of the United States of America, in order to form a corporation for the purposes hereinafter stated, pursuant to the laws of the State of Idaho, do hereby certify as follows:

## ARTICLE I

The name of this corporation is: LAMBERT PRODUCE CO.

#### ARTICLE II

The purposes of this corporation shall be:

Section 1. To engage in commerce, and therein in agricultural, livestock and timber and related businesses.

Section 2. To grow, purchase, acquire, own, sell, market, broker and dispose of farm crops, poultry and dairy products, fruits, vegetables, livestock, timber and lumber, of every kind and nature.

Section 3. To purchase, acquire, lease, own, hold, exchange, improve, mortgage and operate any real or personal property reasonably necessary or useful in connection with the objects or purposes of the corporation.

Section 4. To maintain and operate warehouse facilities and other buildings for the receiving, storing, handling, caring, treatment, sorting and other improvement of products, and for conducting any business of the corporation.

Section 5. To in all forms and manner acquire real and personal property, or interest therein, and transfer and dispose of the same.

Section 6. To enter into, make, perform and carry out contracts of every sort and kind which may be reasonably necessary or desirable for the furtherance of the business of the corporation, to make loans or advances to person or persons, corporations or associations in connection with the business of the corporation and to borrow money for and on behalf of the corporation in connection with such business.

Section 7. To adopt, apply for and register, purchase, lease or otherwise acquire, and sell, assign or grant, licenses or other rights with respect to trademarks, trade names, patents, patent rights, inventions, formulas, copyrights and trade secrets.

Section 8. To perform all acts as are necessary and expedient to accomplish the purposes of the corporation.

#### ARTICLE III.

The term of existence of this corporation shall be perpetual.

#### ARTICLE IV.

The location and post office address of the registered office of the corporation in the State of Idaho shall be P.O. Box 561, Blackfoot, Bingham County, Idaho.

## ARTICLE V.

The amount of the total authorized stock of this corporation shall be \$150,000.00 divided into 1500 shares of \$100.00 par value, common stock, non-assessable, and the rights appertaining thereto shall be in all respects equal, and the shares may be increased or decreased as provided by the laws of the State of Idaho.

#### ARTICLE VI.

Managment of this corporation shall vest in a board of directors composed of three persons.
