

**ARTICLES OF INCORPORATION  
OF  
WEISER CHIROPRACTIC CENTER, P.A.**

The undersigned, each of whom is duly licensed to practice the profession of Chiropractic in the State of Idaho, desire to form a professional corporation pursuant to the Idaho Professional Service Corporation Act for the purpose of rendering chiropractic health services, and adopt the following articles of incorporation for such corporation:

**Article I: NAME**

The name of the corporation shall be: Weiser Chiropractic Center, P.A.

**Article II: DURATION**

The period of its duration is perpetual.

**Article III: PURPOSES AND POWERS**

The purpose for which the corporation is formed is to engage in the general practice of Chiropractic.

In connection with the above-mentioned purpose, the corporation shall have the power to invest its funds in real property and securities, to acquire, own, and dispose of real and personal property, and to do all other acts to the extent permitted under the Idaho Professional Service Corporation Act.

**Article IV: PRINCIPAL OFFICE**

The address of the principal office of the corporation in the State of Idaho is: 25 West Main Street, City of Weiser, County of Washington, 83672, and the name of the initial registered agent at such address is: Alan L. Waite, D.C..

## Article VI: DIRECTORS

The corporation shall be governed by a board consisting of one director, which number may be increased by the bylaws of the corporation. Directors shall be stockholders in the corporation and shall be elected by the stockholders.


## Article VIII: PREEMPTIVE RIGHTS
